WELCOME Chair David Fisher welcomed everyone and thanked them for joining today.

MINUTES David Fisher requested a motion to approve the minutes from the August 16, 2024, Foundation Board Meeting. Scott Hart made the motion; Matt Mucci seconded it. All members voted affirmatively, and the motion passed.

PRESIDENT'SPolk State College President Dr. Angela Garcia Falconetti invited the Board to the Haines **REMARKS** City-Davenport Campus Groundbreaking ceremony scheduled for Thursday, November 21, 2024, at 10:00 a.m. She went on to speak about a letter she wrote to the editor of the Ledger Newspaper and reviewed an article from "Florida Trend 500".

NEW BUSINESS Chair David Fisher advised that a vote was required to provide Dr. Angela Garcia Falconetti with the Country Club of Winter Haven membership. David advised that after speaking to attorney Don Wilson, he learned that an educational institution cannot pay for membership

dues. Therefore, the Foundation has been asked to provide the funds. David spoke about how this secluded, private, and comfortable location would be good for donor relationships and essential conversations.
